The Code of Good Governance is a voluntary set of standards on good governance practice for the boards of voluntary and community organisations. It was first launched by the <u>Developing Governance Group</u> in 2008 and revised in 2016 following consultation with the voluntary and community sector, and has been widely accepted as the set of standards of governance for the sector.

The Developing Governance Group has been reviewing The Code and would welcome your comments on its draft revised Code. The Group are asking you to complete an online survey to gather responses to ensure that this revised Code of best practice is relevant and appropriate for the needs of voluntary and community organisations.
